

Cookie Policy

This Cookie Policy outlines how Deskpro Ltd. and its affiliates (collectively "Deskpro", "we", "us", "ours") operate with transparency and diligence with regards to how we use your information. This Cookie Policy covers cookies and tracking tools that are used when you visit our websites, use our products or software, and any additional features as part of the Services that Deskpro makes available to you on a trial or paid basis.

What is a cookie?

A cookie is a small text file that can be placed on your computer or mobile device when you visit a website, app or software platform. They are used to identify your browser and activities of your computer or mobile device on the Deskpro Service and other websites. Any cookie that is set by the website, app or platform owner is known as a "first party cookie". Whereas a cookie set by parties other than the website, app or platform owner is known as a "third party cookie." They are used for things like advertising and analytics, and allow organisations to show adverts on other websites.

Why do we use cookies?

We use both first and third party cookies for a number of reasons, including to personalise your experience of Deskpro. Some cookies are essential for us to provide the features in the Service across our websites, apps and software platform. Other cookies are used to allow us to statistically monitor how you use Deskpro, so we can improve our Services. By using cookies, we are able to improve the service that Deskpro provides to you and measure the effectiveness of our marketing campaigns. Please be aware that this Cookie Policy does not cover or govern the use of third party websites or services.



Types of cookies?

Cookies fall into one of the following categories:

Essential cookies

These cookies are essential in order for us to provide the features that make up the Services. For example, remembering you have logged in.

Analytics cookies

These cookies collect information on how visitors to our Websites interact with them. These are used to allow us to identify how we can improve your experience of the Websites and marketing campaigns.

Performance cookies

These cookies are non-essential but are used to help enhance the performance and functionality of our Websites. Without some of these cookies, some functionality may not be possible.

Advertising cookies

These cookies are used to create more relevant advertising messages for you. They collect information about your browsing habits to improve your advertising experience.

Social media cookies

These cookies allow you to share content or pages from our Websites, that you find interesting, to third party social media sites. These cookies may also be used for advertising activities.

Other Tracking Technology

They are tiny graphic files that are used to help track website, app, product or email usage information, for example how many times a specific email or page has been viewed. In many instances, these technologies are reliant on cookies, so rejecting cookies will prevent their functioning.
